Final project

Project (with research methods element)

This module provides the opportunity for students to undertake the MBA Project, a self-managed process of systematic practitioner inquiry, to address a management challenge with the option of working with an organisation. This project enables students to integrate, apply and develop the knowledge and skills that they have acquired during the MBA programme.

Students will be allocated a supervisor for their MBA project who will support their process of independent learning and inquiry. Supervisory contact hours will include feedback on one draft chapter, progress check-ins, and ongoing Q&A.

Teaching and assessment

The learning, teaching and assessment strategies for all online programmes are aligned with the three University of Liverpool hallmarks of research-connected teaching, active learning and authentic assessment – as well as the three University of Liverpool Graduate attributes of confidence, digital fluency and global citizenship.

You'll take modules totalling 120 credits, with the dissertation or consultancy based project completed at the end of your studies being worth 60 credits. You'll be supported by your academic supervisor during the dissertation or consultancy based project.

You're required to complete 180 credits to achieve a full MBA. Subject to meeting specific criteria outlined by the University, you'll graduate with a Pass, Merit or Distinction.

How you'll study

Studying online allows you to study in your own time and from wherever works best for you – whether that is from your home, during your lunch hour or anywhere else you

have internet access.

With online FIMBA, you can study in your time and wherever through live and recorded sessions. All our online programmes are delivered through **Canvas**, the University's Virtual Learning Environment, enabling you to thrive in a flexible and engaging hybrid approach.

Assessments

Online programmes are assessed based on work carried out in the virtual classroom. Reflecting the hallmark of authentic assessment, this may include report writing, reflective practice, research projects, and individual or group presentations that represent the kinds of tasks you would be expected to undertake in a professional setting. There is also one exam (delivered online) within the Managing Financial Resources module.

The weighting of individual components will vary from one module to another. All assessment information is included within the module handbook at the start of each module.

Online learning experience

We will support your online learning experience with high-quality learning materials and resources, which can all be found on Canvas.

Typically, your learning experience will include the following:

 directed learning – including participation in virtual discussions with peers, led by the lecturer, working through relevant and specially prepared videos and lecturecasts; completing interactive exercises on the learning platform; and appointments with your lecturer during office hours

- **self-directed learning** including wider reading and research in your subject area to further develop your knowledge and understanding
- **assessment** time taken to prepare and complete assignments and activities which contribute to your overall assessment.

On average, you will need to dedicate a minimum of 15-20 hours of study per module, per week.

Your tuition fees, funding your studies, and other costs to consider.

Tuition fees

UK fees (applies to Channel Islands, Isle of Man and Republic of Ireland)

Part-time place, per year - £12,975

International fees

Part-time place, per year - £16,475

Fees are for academic year 2025/26. Please note our MBA programmes include one optional international study trip to a European destination. The University covers the cost of accommodation and excursions only. This is scheduled to take place in the January of your first part time year of study. The University does not cover any additional costs associated with the trip, such as flights and visa applications. The School cannot guarantee that visa applications connected with the study trip will be successful. The visa application process is managed by the student independent of the university. The University in its decision making, ensure the choice of destination has reasonable visa requirements and costs. Fees will not be refunded to students who do not participate in the international study trip.

Tuition fees cover the cost of your teaching and assessment, operating facilities such as libraries, IT equipment, and access to academic and personal support.

- You can pay your tuition fees in instalments.
- All or part of your tuition fees can be <u>funded by external sponsorship</u>.
- International applicants who accept an offer of a place will need to <u>pay a</u> <u>tuition fee deposit</u>.

If you're a UK national, or have settled status in the UK, you may be eligible to apply for a Postgraduate Loan worth up to £12,167 to help with course fees and living costs. **Learn more about paying for your studies.**

We understand that budgeting for your time at university is important, and we want to make sure you understand any course-related costs that are not covered by your tuition fee. This could include buying a laptop, books, or stationery.

Postgraduate entry requirements

Candidates will normally be expected to hold a 2:1 Honours degree (which may be in any discipline) from a UK university, or an equivalent professional qualification from a similar non-UK institution.

Non-graduates who possess extensive professional experience (more than 5 years) and/or a postgraduate qualification are encouraged to apply.

Non Standard Entry

Non Standard entry relates to applicants who may not hold a degree or the required degree classification. We would still encourage applications if you have

- Significant management experience (more than 5 years),
- Below 2:1 or no formal university degree
- Substantial record of achievement in business and leadership (for example accredited training courses, learning & development courses).

Each application is considered on a case by case basis and will include an informal, online interview with the MBA team. The interview is an opportunity to discuss your suitability to MBA programme, your experience and interest in the MBA programme.

International qualifications

Select your country or region to view specific entry requirements.

Many countries have a different education system to that of the UK, meaning your qualifications may not meet our entry requirements. Completing your Foundation Certificate, such as that offered by the <u>University of Liverpool International College</u>, means you're guaranteed a place on your chosen course.

English language requirements

You'll need to demonstrate competence in the use of English language, unless you're from a majority English speaking country.

We accept a variety of <u>international language tests</u> and <u>country</u>specific qualifications.

International applicants who do not meet the minimum required standard of English language can complete one of our <u>Pre-Sessional English courses</u> to achieve the required level.

If you don't meet our English language requirements, we can use your most recent IELTS score, or <u>the equivalent score in selected other English language tests</u>, to determine the length of Pre-sessional English course you require.
